

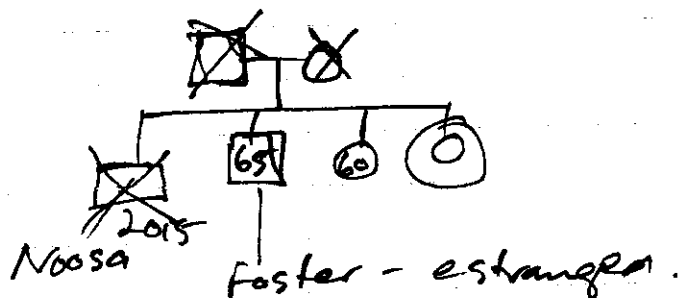

Daughter 12-18mos when separated.
Proved I could survive -
He moved on + had g. friend

Met Chris at work - Paramatta. 1991.
Sen. Constable & cells + in courts.
Then went to city job.
We got on well. A few years after we went out.
S.T.O.G. - in '90s - already been = STOG once
Suicide attempts at home.

He'd do + say horrible things out of frustration +
anger - if people didn't do what he wanted.

If I called police, was never recorded.
Looked after each other.

Everything was OK at 1st.
Treated 1st daughter terribly.
He tried to kill his best mate.
Dx PTSD + S.I.
'never able to work again since 2000'

Went away a work football trip.

always thought he was above the law.
Not allowed to see his kids.
Proud of uniform. To get sick hard for him.

Tried to help him but gave up in the end
as he not willing to help himself.

I protected the kids when things happening.

Bident turned out OK
Youngest - anxiety

From age 8 - F. got custody to live
in twice.

I picked her up at 16.

10yr - lived in my S. He c/o I was unfit
M.

He turned up at my house for a while.
Kimberley - told stories of her F. being naked
to her. School denied it.

Age of 10, court took her & my S took her
so didn't go into foster care.

I was only allowed to see her supervised once
a week.

Finally went to court & he manipulated system
- put in his custody. Lived in him for 18 mos.
My SIL said can't live there anymore.
My S. had to agree to go to U.S. for
her kids.

→ rift in family.

M. Dx Hodgkin's. I was cancer & moved in to
parents. But siblings never available to help
Eldat = Jade.

My siblings believed him over me.

Parents knew

Chris wanted to put me in S/G saying I
had bipolar. Told my parents to get them to
take me to hospital.

Parents talked to girl friend & believed me.

Held me inside house so I didn't leave.
